- 9 stories have been identified as a good height. Currently zoned for 6 so they are applying for an amendment.
- Would encourage the BIA to delegate on proposals. We would like retail space in these new builds that are 3000 to 5000 square feet.
- Ward One Right across from Mapleview mall. The heritage will be saved and moved to the front and the 20 stories will be built in the back. COB is encouraging development in these growth modes.
